## Introduction

Thank you for purchasing the TLV free float steam trap.

This product has been thoroughly inspected before being shipped from the factory. When the product is delivered, before doing anything else, check the specifications and external appearance to make sure nothing is out of the ordinary. Also be sure to read this manual carefully before use and follow the instructions to be sure of using the product properly.

This free float steam trap uses a two-bolt flange, an X-element air vent and three-point seating for a precision-ground float, increasing heating efficiency and reducing manpower requirements for maintenance.

The two-bolt flange allows the trap to be installed in either horizontal or vertical piping. This flexibility greatly reduces the time required for installation, removal, repair and maintenance.

The three-point seating supports the precision-ground float securely and ensures a high degree of sealing for even minute quantities of condensate. The X-element is very sensitive to changes in temperature, and responds with great accuracy, quickly discharging air and the large quantities of condensate created immediately after operation startup, thereby greatly reducing start-up time. It also reacts with great sensitivity to the inflow of large quantities of condensate and hot air during operation, preventing air binding.

If detailed instructions for special order specifications or options not contained in this manual are required, please contact TLV for full details.

This instruction manual is intended for use with the model(s) listed on the front cover. It is necessary not only for installation, but for subsequent maintenance, disassembly/reassembly and troubleshooting. Please keep it in a safe place for future reference.

## **Safety Considerations**

- Read this section carefully before use and be sure to follow the instructions.
- Installation, inspection, maintenance, repairs, disassembly, adjustment and valve opening/ closing should be carried out only by trained maintenance personnel.
- The precautions listed in this manual are designed to ensure safety and prevent equipment damage and personal injury. For situations that may occur as a result of erroneous handling, three different types of cautionary items are used to indicate the degree of urgency and the scale of potential damage and danger: DANGER, WARNING and CAUTION.

#### Caution

#### Caution

Always wear eye protection and heat-resistant gloves when operating the blowdown valve. Failure to do so may result in burns or other injury.



#### Caution

When operating the blowdown valve, stand to the side well clear of the outlet to avoid contact with internal fluids that will be discharged. Operate the valve slowly and surely, taking care to avoid the area from which internal fluids are discharged and any fluids deflected off piping or the ground etc. Failure to do so may result in burns or other injury.



#### Caution

Do not tighten the BD2 valve or the BD2 valve seat in excess of the appropriate tightening torque. Over tightening may cause breakage to threaded portions, which may cause burns, other injuries or damage.



#### Caution

Do not excessively loosen the BD2 valve when opening the blowdown valve. The valve stopper pin installed to prevent the BD2 valve from being removed may break and internal pressure may result in the BD2 valve being blown off, leading to injuries, damage and fluid discharge, causing burns.

## **Checking the Piping**



#### Caution

**Use only under conditions in which no water hammer will occur.** The impact of water hammer may damage the product, leading to fluid discharge, which may cause burns or other injury.

Check to make sure that the pipes to be connected to the product have been installed properly.

- 1. Is the pipe diameter suitable?
- 2. Has sufficient space been secured for maintenance?
- 3. Have isolation valves been installed at the inlet and outlet? If the outlet is subject to back pressure, has a check valve (TLV-CK) been installed?
- 4. Is the inlet pipe as short as possible, with as few bends as possible, and installed so the liquid will flow naturally down into the product?
- 5. Has the piping work been done correctly, as shown in the figures below?
- 6. Using the appropriate tools, have the screws been tightened enough?



## **Operation**

Principles of air and condensate discharge:


#### 1. Air and Cold Condensate Discharge at Startup

At startup, before steam is supplied, the trap is cold, the X-element is contracted and the air vent valve seat (A) is open. This allows for the rapid discharge of air through the air vent valve (A) and cold condensate through the orifice opening (B), when steam is first supplied to the system.




#### 2. Condensate Discharge

After the discharge of initial air and cold condensate, the heat of the inflowing steam and condensate causes the X-element to expand, closing the air vent valve (A). The rising condensate level causes the float to rise due to buoyancy, opening the orifice (B) and allowing condensate to be discharged.




#### 3. Hot Air Discharge

Should hot air flow into the trap with the steam during normal operation, the temperature of the X-element drops, causing it to momentarily contract and open the air vent valve (A), which allows for the rapid discharge of the air. After the air is discharged and steam contacts the X-element, the temperature will increase causing the air vent valve (A) to close.



#### 4. Closed Position

When the condensate flow rate decreases, the float falls as condensate is discharged, closing the orifice (B). A water seal is maintained at all times over the orifice (B) to prevent steam loss.







- The J32-X trap unit is compatible with trap stations (V1/V2/V1P/V2P Series) and Quick Station QS10, and can also be installed on connector unit F32.

The connector unit name is embossed on the connector body.

## Installation



**Take measures to prevent people from coming into direct contact with product outlets.** Failure to do so may result in burns or other injury from the discharge of fluids.

Installation, inspection, maintenance, repairs, disassembly and adjustment and valve opening/closing should be carried out only by trained maintenance personnel.

- 1. Before installation, be sure to remove all protective seals.
- 2. Before installing the product, blow out the inlet piping to remove any piping scraps, dirt and oil. Close the inlet valve after blowdown.
- 3. Install the product so the arrow on the body is pointing in the direction of flow.
- 4. The connector body has no restrictions on installation orientation except for the following conditions: the flange face (for connecting to the trap unit) must be in the vertical plane, and the trap unit must be installed with the nameplate facing upwards.
- 5. The trap unit must be inclined no more than 5° horizontally and front-to-back.
- 6. Install a condensate outlet valve and outlet piping.
- 7. Open the inlet and outlet valves and ensure that the product functions properly.

If there is a problem, determine the cause using the "Troubleshooting" section in this manual.



Install with the arrow on the connector body pointing in the direction of flow, with the flange (for connecting to the trap unit) in the vertical plane and the trap unit with the nameplate facing upwards.





#### For screwed connection:

When products with screwed connections are installed on horizontal piping, there is a danger that the weight of the trap unit will cause the connector body to rotate on the pipe, putting the trap mechanism out of the horizontal plane. To prevent this, tighten the screws securely. In cases where the product is affected by vibrations or by external contact, it is recommended that the trap unit should be supported to prevent rotation (sample support shown to the right).

## **Maintenance**



#### Caution

Be sure to use only the recommended components when repairing the product, and NEVER attempt to modify the product in any way. Failure to observe these precautions may result in damage to the product and burns or other injury due to malfunction or the discharge of fluids.

#### **Operational Check**

A visual inspection of the following items should be done on a daily basis to determine whether the product is operating properly or has failed. Periodically (at least biannually) the operation should also be checked by using diagnostic equipment such as a stethoscope, thermometer, TLV Pocket TrapMan or TLV TrapMan.

If the product should fail, it may cause damage to piping and equipment, resulting in faulty or low quality products or losses due to steam leakage.

Normal: Condensate is discharged continuously, together with flash steam, and the

sound of flow can be heard. If there is very little condensate, there is almost

no sound of flow.

Blocked No condensate is discharged. The product is quiet and makes no noise, and the

(Discharge surface temperature of the product is low.

Impossible):

Blowing: Live steam continually flows from the outlet and there is a continuous metallic

sound.

Steam Leakage: Live steam is discharged through the product outlet together with condensate,

accompanied by a high-pitched sound.

(When conducting a visual inspection, flash steam is sometimes mistaken for steam leakage. For this reason, the use of a steam trap diagnostic instrument such as TLV TrapMan in conjunction with the visual inspection is highly recommended.)

#### **Parts Inspection**

When parts have been removed, or during periodic inspections, use the following table to inspect the parts and replace any that are found to be defective.

Gaskets: Check for warping or scratches Screen: Check for clogging or corrosion

X-element: Check for scratches

Air Vent Valve Seat: Check for scratches

Float: Check for scratches or dents Body Interior: Check for build-up

Orifice Opening: Check for dirt, oil film wear or scratches

## Disassembly/Reassembly


#### **Detaching/Reattaching the Trap Unit and Connector Body**

Part Name & No.	During Disassembly	During Reassembly
Connector Bolts 23	Remove with a socket wrench	Consult the table of tightening torques and tighten to the proper torque
Trap Unit	Remove the trap unit	Follow the special instructions below (see Fig. A)

#### Attaching the Trap Unit to the Connector Body

- 1. If attaching a new trap unit, be sure to remove the protective cap from the connector flange. Be careful not to drop the gaskets when removing the cap.
- 2. Grasp the end of the trap unit and align its gasket housing with the indentation on the connector body.
- 3. Once aligned, insert and finger tighten the connector bolts. Verify that the trap unit is within the allowable inclination.



# **Instructions for Plug/Holder Disassembly and Reassembly**


The seal on the threaded plugs/holders found on TLV products is formed by a flat metal gasket. There are various installation orientations for the gaskets, such as horizontal, diagonal and downward, and the gasket may be pinched in the thread recesses during assembly.

#### **Instructions for Disassembly and Reassembly**


- 1. Remove the plug/holder using a tool of the specified size (distance across flats).
- 2. The gasket should not be reused. Be sure to replace it with a new gasket.
- 3. Clean the gasket surfaces of the plug/holder and the product body using a rag and/or cleaning agents, then check to make sure the surfaces are not scratched or deformed.




4. Coat both the gasket surface of the plug/holder and the threads of the plug/holder with anti-seize, then press the gasket onto the center of the gasket surface of the plug/holder, making sure the anti-seize affixes the gasket tightly to the plug/holder. Check to make sure the gasket is not caught in the recesses of the threads.



5. Hold the plug/holder upside down to make sure that the anti-seize makes the gasket stick to the plug/holder even when the plug/holder is held upside down.



6. Screw the plug/holder by hand into the product body while making sure that the gasket remains tightly affixed to the center of the gasket surface of the plug/holder. Make sure the entire gasket is making contact with the gasket surface of the product body. It is important at this point to make sure the gasket is not pinched in the thread recesses of the plug/holder.



- 7. Tighten the plug/holder to the proper torque.
- 8. Next, begin the supply of steam and check to make sure there is no leakage from the part just tightened. If there is leakage, immediately close the inlet valve and, if there is a bypass valve, take the necessary steps to release any residual pressure. After the surface of the product cools to room temperature, repeat the procedure beginning from step 1.

## **Troubleshooting**



#### Caution

When disassembling or removing the product, wait until the internal pressure equals atmospheric pressure and the surface of the product has cooled to room temperature. Disassembling or removing the product when it is hot or under pressure may lead to discharge of fluids, causing burns, other injuries or damage.

When the product fails to operate properly, use the following table to locate the cause and remedy.

Problem	Cause	Remedy
No condensate is discharged	The float is damaged or filled with condensate	Replace with a new float
(blocked) or discharge is poor	The orifice opening, screen or piping are clogged with rust and scale	Clean parts
	The X-element is scratched or damaged	Replace with a new X-element

	The product operating pressure exceeds the maximum specified pressure, or whether there is insufficient pressure differential between the product inlet and outlet	Compare specifications and actual operating conditions


When operating the blowdown valve, stand to the side well clear of the outlet to avoid contact with internal fluids that will be discharged. Operate the valve slowly and surely, taking care to avoid the area from which internal fluids are discharged and any fluids deflected off piping or the ground etc. Failure to do so may result in burns or other injury.

Do not tighten the BD2 valve or the BD2 valve seat in excess of the appropriate tightening torque. Over tightening may cause breakage to threaded portions, which may cause burns, other injuries or damage.

**Do not excessively loosen the BD2 valve when opening the blowdown valve.** The valve stopper pin installed to prevent the BD2 valve from being removed may break and internal pressure may result in the BD2 valve being blown off, leading to injuries, damage and fluid discharge, causing burns.

#### **TLV Blowdown Valve: BD2**

The BD2 Blowdown Valve, installed in the screen area of the body, uses the trap's internal pressure to blow any condensate, steam, dirt or scale accumulated around the screen area out to the atmosphere.

#### **BD2 Blowdown Valve Operation**

- 1. The BD2 valve is in the closed position when the BD2 is shipped from the factory. Before attempting to operate the BD2, reconfirm that the BD2 valve is still in the closed position. Locate the blow outlet and, during operation, stand to the side and well clear of it, as the jet of condensate or steam could cause burns.
- 2. Remain in the area the entire time the BD2 valve is in the open position. Before opening the BD2 valve, grip the BD2 valve seat with a wrench and hold firmly in place so that it will not rotate when the BD2 valve is loosened. Grip the BD2 valve with another wrench and slowly loosen. Condensate and steam will discharge from the blow outlet in a jet stream. Be careful not to loosen the BD2 valve so far that it becomes removed from the BD2 valve seat. (If the valve stopper pin becomes damaged, large quantities of steam will be discharged in a jet stream.)
- 3. Close the BD2 valve until the flow of fluid completely stops. If the flow of fluid does not stop, re-open the BD2 valve (as in step "2") to blow out any scale or dirt that may be caught in the BD2. Re-tighten the BD2 valve until the flow of fluid stops completely.


#### **Lock Release Valve**

Use heat-resistant gloves when operating the lock release valve and keep all body parts well clear of the product. Failure to do so could result in burns, other injury or damage from the blowing of small amounts of steam and condensate.

Use on equipment where steam-locking or air-binding, which slows the discharge of condensate and reduce equipment efficiency, tends to occur (cylindrical dryers, air fin heater, etc.).




## **Operating Instructions for Needle Valve Unit**

- 1. When the product is shipped from the factory, the element retainer is raised in the maximum, valve-closed position.
- 2. Before operating the lock release valve, examine the trap outlet and confirm that the trap is functioning properly.
- 3. Operate the lock release valve as follows: (tools required: flat-head screwdriver)
  - Open Valve Insert the screwdriver into the slot on the top of the element retainer and slowly turn clockwise. (Do not turn the element retainer past the point at which it stops.) See charts below for steam discharge/air discharge. (Maximums are shown.)
  - Close Valve Insert the screwdriver into the slot on the top of the element retainer and close by turning counterclockwise. Raise the element retainer until the snap ring contacts the bottom of the gland case. (Do not turn the element retainer past the point at which it stops.)
- 4. If steam should leak from the gland retainer nut or gland case, it can be stopped by further tightening the gland retainer nut. (Do not over tighten, otherwise element retainer may seize and become unworkable.)



#### Operating Instructions for Lock Release Valve

- 1. When shipped from the factory, the needle valve is in the closed position.
- 2. To operate the needle valve, insert a flat-head screwdriver into the slot on the top of the needle valve and:
  - Open Valve: slowly turn counterclockwise. (Do not continue turning the needle valve past the point at which the snap ring contacts the bottom of the gland case.)
  - Close Valve: slowly turn clockwise. (Do not continue turning the needle valve past the point at which it stops.)
- 3. If steam should leak from the gland retainer nut or gland case, it can be stopped by further tightening the gland retainer nut. (Do not over tighten, otherwise the needle valve may seize and become unworkable)
